Sub: Minutes of the Meeting held on 29.05.2023 at 12.00 Noon under the Chairmanship of Secretary (Power) to discuss various issues related to DVB Pensioners and DVBETBF Pension Trust.

A meeting was held on 29.05.2023 at 12.00 Noon under the Chairmanship of Secretary (Power)/Chairman (Pension Trust) to discuss various issues related to DVB Pensioners and DVBETBF Pension Trust.

A list of officers who attended the meeting is enclosed as **Annexure -A**.

The following issues were discussed /decided:

1. The issue related to Cashless Medical facility was discussed in the meeting wherein it was decided that the matter is under consideration and decision will be taken in due course after careful examination of the issue.
2. The officers of pension trust informed that approval of 150 hospitals has been received for empanelment with DVBETBF. It was directed to process the empanelment of hospitals immediately from whom consent has been received.
3. It was informed that around 700 cases are pending for pay fixation. It was directed to Pension Trust to place these cases before the committee constituted in DTL under the chairmanship of Spl. Secretary (Power)/Director (HR), DTL.
4. The issue of LTC, electricity concession and extension of electricity concession to the family pensioner to be put up separately on file by the Pension Trust expeditiously for the decision of the Government.

5. It was informed that pension of Ex-Chief Engineers has been reduced. Pension Trust informed that the matter has already been referred to the companies for necessary action and action taken report shall be obtained expeditiously.
6. The issue related to applicability of Govt orders on pension trust was discussed. It was decided that the matter be put up separately on file by the Pension Trust for the decision of the Government considering the applicability of FR/SR and tripartite agreement.
7. It was further directed that a Grievance Desk to be created immediately in Pension Trust for timely resolution of the grievances of the pensioners.
8. The pensioner Association submitted in the meeting that there are few issues with disbursal of pension through SBI. It was directed to pensioner association to share the details of individual cases/problems with pension trust for necessary action.
9. The issue for new ID cards of pensioners was raised in the meeting. Pension Trust was directed to put up the matter in file.
10. Pension Trust was directed in the meeting to examine and put up the matter for issuing directions to DERC to open an escrow account for receiving pension surcharge amount for passing the funds directly to Pension Trust.
11. It was decided in the meeting that housekeeping of pension trust building will be taken care by the DTL.

Meeting ended with vote of thanks to the Chair.
