**OFFICE ORDER**

The Board of Trustees, DV BETBF-2002 in the meeting held on 30.12.2019 has accorded the approval for the following guidelines regarding medical facilities for Pensioners/Family Pensioners of Pension Trust in respect of reimbursement of bills, which are hereby circulated for implementation with immediate effect :-

1. No referral from dispensaries is required for availing medical treatment/attendance from Govt./Panel Hospitals.
2. **OPD cases** : For OPD treatment, there will not be any requirement of verification/counter verification of claims from opted dispensary/CMO office and need of submission of empty strips of medicines by the claimant stands dispensed with. The beneficiaries shall submit OPD claims in Pension Trust with duly filled-in Medical claim form, Certificate 'A' (in case of hospital treatment), self verified payment receipts in original and photocopies of prescriptions etc. The reimbursement will be done by DVB ETBF-2002 as per DGEHS/CGHS rates as amended from time to time.
3. OPD bills of Rs. 50,000/- and above per month of an individual shall be scrutinized by CMO, IPGCL and reimbursed as per rules.
4. **IPD cases** : Cash payment bills of admitted cases (In Patient treatment) shall be checked strictly w.r.t DGEHS/CGHS rates only, by the CMO, DTL and reimbursed as per rules.
5. **Premier category hospitals (category-III)** : No prior permission is required for availing treatment from Premier category hospitals. The treatment from these hospitals shall be restricted to DGEHS/CGHS listed procedures and investigations only and the reimbursement shall be done strictly as per DGEHS/CGHS rates.
6. Vaccination expenses shall be reimbursed by Pension Trust as per DGEHS rates.
7. Existing medical facilities from Rajiv Gandhi Cancer Hospital shall continue without any modification.
8. The beneficiaries who settled permanently in any state outside Delhi with official intimation to Pension Trust, can avail treatment from any hospital empanelled with CGHS near their residence. However, treatment shall be restricted only to the CGHS listed procedures, investigations and the reimbursement shall be done as per CGHS rules.
